




2015 World Development Indicators Featuring ICP 2011 Results

Developing countries have a higher share of world GDP

Purchasing power parity (PPP) estimates based on the 2011 round of the International Comparison Program were incorporated into *World Development Indicators* in 2014, replacing the extrapolated PPP estimates based on the 2005 round. When comparing the 2011 results to the 2005 results, high-income countries' share in the world economy is about 4.5 percentage points smaller, lower middle-income countries' share is 3.4 percentage points larger, and upper middle-income countries' share is 0.9 percentage point larger. Compared with estimates based on market exchange rates, lower middle-income and low-income countries' PPP-based shares are more than double, upper middle-income countries' share is more than 30 percent greater, and high-income countries' share decreases to half of the world economy from two-thirds.

46th Session of the United Nations Statistical Commission

The 46th session of the United Nations Statistical Commission took place from March 3-6, 2015 in New York. The session on the ICP was held on March 6, 2015 when the Statistical Commission discussed the preliminary report of the Friends of the Chair group on the evaluation of the 2011 round of the ICP and conveyed gratitude for the work undertaken in the ICP 2011 round.

The Commission appreciated the Friends of the Chair report's initial findings of the ICP 2011 round affirming increased country participation, improvements in PPP methodology, increased transparency and documentation, streamlined quality assessment processes, and improved outreach to increase the uses of PPPs. The Commission emphasized that ICP should emerge as a permanent global statistical

program with more frequent ICP rounds.

The complete set of recommendations in the ICP Friends of the Chair final report with a view to transform the ICP exercise into a revolving and more frequent exercise that takes into account users' needs and national statistical capacity will be presented to the 47th session of the Commission in 2016.

In the interim period, the Commission urged countries and regional coordinating agencies to sustain the capacity built during the 2011 round and maintain the momentum. Moreover, the Commission encouraged the World Bank to support regional partners to ensure the continuity of ICP activities.

A meeting on the Evaluation of ICP 2011 was called by the Co-Chairs of the ICP Friends of the Chair group - India's Ministry of Statistics and Programme Implementation and

Statistics Austria - on March 5, 2015 in New York.

The group discussed the conclusions from the UNSC session on the ICP evaluation and the preparation of the ICP Friends of the Chair final evaluation Report.

Meeting of ICP Regional Coordinating Agencies

The meeting of the ICP Regional Coordinating Agencies took place on March 1, 2015 in New York. The meeting discussed activities and efforts planned to estimate PPP updates at the regional level, coordinating efforts to maximize the value of these updates to users, and thoughts about the future of the ICP.


Representatives from Regional Coordinating Agencies including the African Development Bank, Asian Development Bank, CIS-STAT, UN-ECLAC, UN-ESCWA, Eurostat and OECD, as well as the World Bank attended the meeting. The group concurred that the ICP needs to be revamped into a permanent and less costly exercise with lighter governance, producing more frequent, timely and consistent results.

The meeting participants agreed that much great work was planned in the interim period at the regional level, but potential mismatch in timelines and approaches remained challenging. A future meeting in May 2015 was proposed to address these challenges and implement a plan that utilizes planned regional PPP updates to produce the best possible global PPP updates.
