New Global Environment Facility Policy on Stakeholder Engagement

After a two-year consultation process, the Global Environment Facility (GEF) Council approved an updated Policy on Stakeholder Engagement, which will take effect on July 1, 2018, as the GEF starts its seventh cycle (GEF-7). The Policy establishes minimum requirements for all GEF agencies regarding engagement of stakeholders in GEF projects and programs, and introduces monitoring, reporting and documentation requirements in the project cycle. The Global Financing Facility (GFF) engages with CSOs at the sub-national, national and global levels. CAO's Outreach to African Civil Society

The Compliance Advisor Ombudsman (CAO), the independent accountability mechanism for IFC and MIGA, has begun a year-long initiative to reach out to CSOs in the Africa region. The outreach intends to raise awareness of CAO's mandate and how the office works with local communities through dispute resolution and compliance interventions to address environmental and social grievances related to IFC and MIGA projects. Two recent events included participation in an ACCA meeting in South Africa and a video conference with Ghanaian CSOs. Information on upcoming CAO workshops will be available here.



New Environmental and Social Framework: Workshops Underway

Workshops on the World Bank's new Environmental and Social Framework took place this month in the Philippines (February 19-23) and in Ghana, Sierra Leone, and Liberia (February 26-March 1). The workshops consist of: a half day presentation to high level Government officials; a two-day technical training for project implementation staff; and half day awareness session with other stakeholders that include civil society and development partners. The next series of workshops will take place in Nigeria, Bangladesh and Macedonia FYR in April.
