1. Background

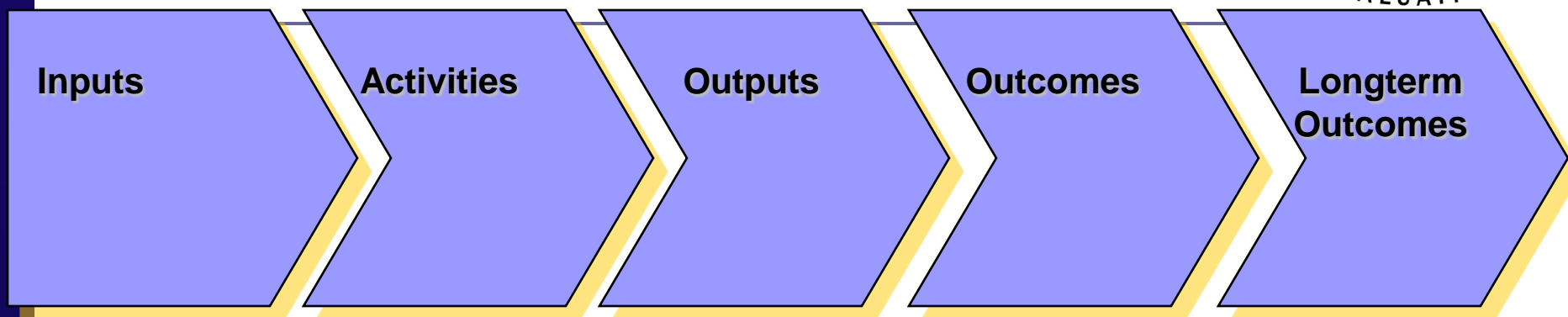
- Deepen health care reform
- Provide equal access to public health services
- Conduct regular prenatal health checks for pregnant women

Issues

- Poor coverage
- Poor quality of service (esp. in rural areas)



2. Results Chain



- 80% payment by number of prenatal care services provided

- 20% payment by quality of prenatal care services

- Design package for prenatal care services
- define quality measurements for prenatal care services

- Purchasing contracts for prenatal care services

- provision of high quality of prenatal care services

- Improve the quality and increase the coverage of prenatal care services received by pregnant women

- Improve health status of women and new born children

3. Primary Research Question



What is the impact of the new payment system on the coverage and quality of pre-natal services for pregnant women?

4. Outcome Indicators

- ❑ **Service satisfaction rate among pregnant women**
- ❑ **Percentage of women who have received prenatal health checks in the first trimester**
- ❑ **Percentage of women who have received prenatal health checks according to health check protocol**
- ❑ **Percentage of women who are checked up 5 times during their pregnancy**
- ❑ **Incidence of birth defects**
- ❑ **Maternal mortality**
- ❑ **Neonatal Mortality**

5. Identification Strategy/Method

- Matching
- Randomization
- Diff-in-diff

6. Sample and data

- Fujian province---Quanzhou city and Nanping city
- 18 counties
 - Quanzhou city :8 counties, 4 counties for treatment,4 for control.
 - Nanping city: 10 counties,5 counties for treatment,5 for control.
- Matching counties
- Randomization for treatment group and control group

Data collection

- Government data
- Health authorities data
- Facility survey: pregnant women checks
- Household data
