



ICP at the United Nations Statistical Commission

The 48th Session of the United Nations Statistical Commission (UNSC) took place on March 7-10, 2017 in New York. The UNSC discussed the [World Bank report](#) describing the global and regional efforts to launch the 2017 comparison cycle and establish the ICP as a permanent program.

The Commission appreciated the efforts of the agencies implementing the ICP and expressed its satisfaction with the governance, technical, capacity building, advocacy and funding activities undertaken thus far. The Commission also endorsed the governance framework and the composition of the Governing Board. It urged participating countries to integrate and harmonize ICP activities within their regular work program to ensure a sustainable and a truly permanent program and stressed the need for promoting the use of ICP data for policy making. The RAB discussed its composition, advisory roles and responsibilities for implementing the regional ICP in line with global guidelines, while recognizing the statistical capacity and data availability in the region.

The first meeting of the Heads of National Implementing Agencies (NIAs) was also organized back-to-back with the RAB meeting on January 11, 2017 in Hanoi.

Heads of NIAs from 20 economies, and representatives from the institutional members mentioned above attended the meeting.

The objective of the meeting was to provide an overview of the ICP's recent global developments and the work plan in its transition to become a permanent program.

ICP Inter-Agency Coordination Group Meeting

The third meeting of the Inter-Agency Coordination Group (IACG) was held in New York on March 5, 2017, in conjunction with the 48th Session of the UNSC. The main objectives of the meeting were to provide updates on regional and global ICP activities and related risk assessments, and to plan for the next IACG meeting.

The meeting was organized and chaired by the World Bank Global ICP Unit. Participants included the representatives from the African Development Bank (AfDB), the Asian Development Bank (ADB), the Interstate Statistical Committee of the Commonwealth of Independent States (CIS-STAT), the International Monetary Fund (IMF), the Organisation for Economic Co-operation and Development (OECD), the Statistical Office of the European Union (Eurostat), the United Nations Economic and Social Commission for Western Asia (UNESCAP), and the United Nations Economic Commission for Latin America and the

The first meeting of the Asia and the Pacific Regional Advisory Board (RAB) for the 2017 cycle of the ICP was held on January 11, 2017 in Hanoi, Viet Nam.

ICP – Asia and the Pacific Regional Workshop

The Regional Training and Technical Evaluation Workshop on the ICP 2017 cycle in Asia and the Pacific was held on February 27-28, 2017 in Bangkok, Thailand. It was organized by the ADB and attended by statisticians from NIAs and representatives from the ADB and the World Bank Global ICP Unit. The workshop reviewed the price data from the final quarter of 2016 for the 2016 Asian PPP Update exercise. The workshop also reviewed implementation guidelines for the ICP 2017 cycle, including governance framework, institutional arrangements, funding, and operational materials including household consumption item list and survey frameworks.

ICP - Africa Regional Workshop

The Regional Technical Workshop on the ICP 2017 cycle in Africa was held on January 30-February 3, 2017 in Lusaka, Zambia. The workshop was jointly organized by the AfDB and the Common Market for Eastern and Southern Africa Secretariat. Participants included price statisticians and national accountants from 49 African countries conducting ICP activities. Representatives from sub-regional organizations and statistical training centers in Africa, and staff from the AfDB and the World Bank Global ICP Unit also attended.

The workshop assessed country readiness for the ICP 2017 cycle and its implementation in Africa. Participants were briefed on the ICP approach and framework. They conducted hands-on trainings on operational materials for the ICP 2017 cycle and reviewed available data sources for PPP time-series.

ICP - Western Asia Regional Workshop

The Regional Validation Workshop on Price Data for the 2016 PPP Estimates in Western Asia was held on February 6-10, 2017 in Cairo, Egypt. The workshop was organized by the UNESCWA. Participants included representatives from national statistical agencies from 9 member countries, the UNESCWA and the World Bank Global ICP Unit. Participants conducted inter-country validation of the price data from the third quarter of 2016 for household consumption, housing rentals, government and gross fixed capital formation. They also discussed the schedule of finalization and release of regional PPPs for 2014-2016.

Meetings on the Participation of Georgia and Ukraine in the ICP

Meetings between Eurostat and [Georgia \(February 6-9, 2017\)](#) and Ukraine (February 13-16, 2017) were held to discuss both economies' participation in the ICP 2017 cycle through linking with the Eurostat-OECD PPP program. The discussions focused on the timing, coverage and frequency of data collection, and on the methodology to be applied.

Sub-national PPPs in India

A training workshop on sub-national PPPs in India was held on February 19-22, 2017 in Delhi, India. The training was provided to India's Ministry of Statistics and Programme Implementation staff, jointly by the ADB and the World Bank Global ICP Unit representatives. The training included preparing India's CPI input data, explaining basic methods, and installing sub-national PPP computation software to create a sound base for sub-national PPP compilation.

Global Poverty and ICP/PPP Workshop

An internal workshop on Global Poverty and ICP/PPP, was organized by the World Bank on February, 15, 2017 in Washington DC.

The workshop discussed the latest ICP results and methodology, as well as current and future uses of PPPs for measuring global poverty.



New ICP Website


