PROFESSOR OF ECONOMICS, UNIVERSITY OF MALAYA


M Niaz Asadullah is Professor at the Faculty of Economics and Administration, University of Malaya. Other current affiliations include: Visiting Fellow at the Global Development Institute, Manchester University, and Research Fellow at IZA Institute of Labor Economics. Niaz is a development economist with research interests in education, labor and gender economics. Prior to moving to Kuala Lumpur, he was an Assistant Professor of Economics at Reading University, UK. He received his DPhil in Economics from the University of Oxford.




### **Shanta Devarajan**

SENIOR DIRECTOR, DEVELOPMENT ECONOMICS, WORLD BANK

Shanta Devarajan is the Senior Director for Development Economics (DEC) at the World Bank. Previously, he was the Chief Economist of the World Bank's Middle East and North Africa Region. Since joining the World Bank in 1991, he has been a Principal Economist and Research Manager for Public Economics in the Development Research Group, and the Chief Economist of the Human Development Network, the South Asia Region and Africa Region. He was a director of the World Development Report 2004, Making Services Work for Poor People. Before 1991, he was on the faculty of Harvard

University's John F. Kennedy School of Government. A member of the Overseas Development Institute's Board of Trustees, and the author or co-author of more than 100 publications, Mr. Devarajan's research covers public economics, trade policy, natural resources and the environment, and general equilibrium modeling of developing countries. Born in Sri Lanka, Mr. Devarajan received his B.A. in mathematics from Princeton University and his Ph.D. in economics from the University of California, Berkeley.



**William Easterly**  
PROFESSOR OF ECONOMICS, NEW YORK UNIVERSITY

William Easterly is Professor of Economics at New York University and Co-director of the NYU Development Research Institute. His books are *The Tyranny of Experts: Economists, Dictators, and the Forgotten Rights of the Poor* (March 2014), *The White Man's Burden: Why the West's Efforts to Aid the Rest Have Done So Much Ill and So Little Good* (2006), and *The Elusive Quest for Growth: Economists' Adventures and Misadventures in the Tropics* (2001). He has authored 70 academic articles, and has written for the *New York Times*, *Wall Street Journal*, and *Financial Times*. He has served as Co-Editor of the *Journal of Development Economics* and is a Research Associate of NBER. *Foreign Policy Magazine* named him among the Top 100 Global Public Intellectuals in 2008 and 2009, and Thomson Reuters listed him as one of the Highly Cited Researchers of 2014.

LEAD ECONOMIST, DEVELOPMENT RESEARCH GROUP, WORLD BANK

Norman Loayza is a Lead Economist in the Development Research Group at the World Bank. He is currently leading the Asia hub of the Research Group, based in Malaysia. He was director of the World Development Report 2014, Risk and Opportunity: Managing Risk for Development. His research has dealt with various areas of economic and social development, including macroeconomic management,

economic growth, microeconomic flexibility, private and public saving, financial depth and stability, natural disasters, and crime and violence. His advisory experience at the World Bank has also ranged across different topics in various regions and countries. A few examples include business environment and economic performance in Latin America; informal and formal labor markets in the Middle East and Northern Africa; public infrastructure gaps in Pakistan and Egypt; savings for macroeconomic stability and growth in Sri Lanka, Georgia, and Egypt; and pro-poor growth in Indonesia and Peru. On external service from the World Bank, he was a Senior Economist at the Central Bank of Chile (1999-2000), where he advised on financial and monetary policy. Norman has edited 10 books and published nearly 50 papers in professional journals and edited volumes. A Peruvian national, he holds a Ph.D. in economics from Harvard University (1994).



**Hamdan Abdul Majeed**

MANAGING DIRECTOR, THINK CITY

Hamdan is Managing Director of Think City, a community-based urban regeneration organisation wholly-owned by Khazanah Nasional Berhad – the investment arm for the Malaysian Government. Think City provides urban policy ideas working with local governments and civil society to deliver urban solutions in Malaysia. Hamdan led the organisation from its pilot phase catalysing urban regeneration in the George Town UNESCO World Heritage Site. Think City has since grown from its early days as a 6-member team based out of George Town, Penang (2009) into a 42-strong multi-disciplinary team with offices in four cities – Butterworth, Johor Bahru, Kuala Lumpur and George Town. Under his stewardship, Think City was able to translate policy into practice, introducing public grants as a tool for urban regeneration. This contributed positively to the regeneration of George Town through more than 200 projects involving conservation, space activation, capacity building and publications. George Town continues to be a model of development and conservation, identified most recently by UNESCO as a regional example of community-led urban regeneration.



### Antoine Mandel

PROFESSOR OF APPLIED MATHEMATICS, UNIVERSITY PARIS 1 PANTHÉON-SORBONNE

Antoine Mandel is professor of applied mathematics at University Paris 1 Panthéon-Sorbonne and research fellow at the Paris School of Economics. He holds a Ph.D. in applied mathematics from University Panthéon-Sorbonne and has been a post-doctoral fellow at the Potsdam Institute for Climate impact research. His works focuses on the development of mathematical and computational models of socio-economic dynamics in the context of climate change using methods from complex systems and mathematical economics. He has worked in particular on the assessment of green growth prospects in Europe, the evaluation of climate risks for the financial system, the diffusion of low-carbon technologies or the analysis of carbon markets. His work has been published in journals such as Nature Climate Change, Economic Theory, or Mathematics of Operations Research. He also has recently an edited a book "*Penser le changement climatique/Thinking about Climate Change*" (in French), which provides an interdisciplinary perspective on the social challenges posed by climate change. Antoine has participated in a number of transdisciplinary research projects in the FP7 and H2020 programs such as GREEN-WIN, which investigates win-win scenario for climate actions, IMPRESSIONS, which investigate high-end scenarios or SIMPOL and DOLFINS, which investigate the relationships between finance and climate change.



### Ha Nguyen

ECONOMIST, WORLD BANK OFFICE OF THE CHIEF ECONOMIST, MIDDLE EAST AND NORTH AFRICA REGION

Ha Nguyen is an Economist in the Office of Chief Economist for the Middle East and North Africa Region (MENA) at the World Bank. He joined the World Bank in July 2009 as a Young Economist after earning a Ph.D. in economics from the University of Maryland, College Park. His research interests are international finance and economic development. His current interest is on the propagation and transmission mechanisms of employment losses.



### **Renato Lima de Oliveira**

ASSISTANT PROFESSOR OF MANAGEMENT, ASIA SCHOOL OF BUSINESS

Renato Lima de Oliveira is an Assistant Professor of Management at the Asia School of Business (ASB), a research affiliate of the MIT Industrial Performance Center (IPC) and a senior fellow of IDEAS-Malaysia. He does research on the political economy of development and state-business relations, particularly in the areas of industrial and innovation policies, energy politics and government accountability. He has also worked as a consultant for energy, environment, and politics, including assignments for the Ministry of Energy of Mexico and the World Bank. Professor Lima de Oliveira received his Ph.D. in Political Science from MIT, a M.A. from the University of Illinois at Urbana-Champaign (UIUC) and B.A. from the Federal University of Pernambuco (UFPE, Brazil). Among his published works is the paper “Can politicians police themselves? Natural experimental evidence from Brazil’s audit courts.” (jointly authored with F. Daniel Hidalgo and J. Canello) which received the best paper award from the Comparative Political Studies journal in 2017.



### **Kian Ming Ong**

DEPUTY MINISTER OF INTERNATIONAL TRADE AND INDUSTRY (MITI), MALAYSIA

Dr. Ong is Deputy Minister of International Trade and Industry (MITI) for Malaysia. He is also the Member of Parliament for Bangi and Assistant National Director for Political Education for the Democratic Action Party (DAP). He holds a PhD in Political Science from Duke University, an MPhil in Economics from the University of Cambridge and a BSc in Economics from the London School of Economics. Prior to his political life, he was formerly a lecturer at UCSI University, a researcher at the Socio-Economic Development and Research (SEDAR) Institute and the Institute of Strategic Analysis and Policy Studies (INSAP) and a consultant with the Boston Consulting Group (BCG) in the Kuala Lumpur office. He enjoys jogging and watching movies in his spare time.



### Çağlar Özden

LEAD ECONOMIST, DEVELOPMENT RESEARCH GROUP, WORLD BANK

Çağlar Özden is a Lead Economist, Development Research Group, World Bank. A Turkish national and a professional migrant, Çağlar received undergraduate degrees in economics and industrial engineering from Cornell University and Ph.D. in economics from Stanford University. He is a fellow of IZA, CreAM and ERF. His research explores the nexus of globalization of product and labor markets, government policies and economic development. He has edited three books and published numerous papers in leading academic journals such as *American Economic Review* and the *Economic Journal*. His current research projects explore the determinants and patterns of global labor mobility, impacts of migrants on destination labor market outcomes, linkages between migration, trade, and foreign direct investment flows, medical brain drain, and linkages between ageing and global economic integration.



### Christopher Parsons

SENIOR LECTURER, UNIVERSITY OF WESTERN AUSTRALIA

Christopher Parsons is a development economist specializing in migration and development. Chris has a PhD in Economics from the University of Nottingham during which time he held a Royal Economic Society Junior Fellowship. Prior to joining UWA, Chris worked as a Research Officer at the International Migration Institute at the University of Oxford, where he also held a William Golding Fellowship at Brasenose College. Before undertaking his PhD, Chris worked as an Economist at HM Treasury, as a Research Officer at the Development Research Centre on Migration, Globalisation and Poverty at the University of Sussex and as an Economic Advisor and ODI Fellow in the Ministry of Trade and Industry in Sierra Leone.



### **Firas Raad**

COUNTRY MANAGER FOR MALAYSIA, WOLRD BANK

Firas Raad, a Jordanian National, is the World Bank Country Manager in Malaysia. He was formerly the Country Manager for Kuwait. Raad joined the World Bank in 2002 as a Senior Health Policy Specialist. More recently, he was working in the Health, Nutrition and Population (HNP) Global Practice. He has extensive health policy experience in various countries in the Middle East and North Africa region. Prior to 2009, Raad focused on implementing health sector reforms in Lebanon, Palestine and Egypt. He also served as the World Bank Human Development Coordinator for the Gulf Cooperation Council (GCC) countries. Between 1997 and 2000, Raad was the Private Secretary for Health Affairs in the Royal Jordanian Court providing health sector reform policy advice.

Between 2009 and 2013, Raad took a leave of absence from the World Bank and worked in the Quartet Mission in Jerusalem, first as an Advisor and later as Head of the Mission, to support Palestinian economic development.

His primary research interests are in health equity, health financing and health systems reform. He is a founding member of several regional and international organizations dedicated to peace-building, sustainable development and global health. He has published several articles on public health and development. He has a PhD in International Health Policy and Economics from the Harvard School of Public Health, and a Master's degree in International Relations from the Johns Hopkins School of Advanced International Studies.



### **Vijayendra Rao**

LEAD ECONOMIST, DEVELOPMENT RESEARCH GROUP, WORLD BANK

Vijayendra Rao is a Lead Economist in the Development Research Group of the World Bank. He integrates his training in economics with theories and methods from anthropology, sociology and political science to study the social, cultural, and political context of extreme poverty in developing countries. Dr. Rao has published on a variety of subjects that include dowries and domestic violence in India, the economics of celebrations, sex work in Calcutta, participatory development, village democracy and deliberation, and inter-disciplinary

approaches to public policy. He co-edited *Culture and Public Action*, and *History, Historians and Development Policy*, and co-authored the 2006 *World Development Report* on Equity and Development. Most recently, with Ghazala Mansuri, he co-authored the World Bank's Policy Research Report on *Localizing Development: Does Participation Work?* Dr. Rao obtained a BA (Economics, Statistics, Sociology) from St. Xavier's College - Bombay (now Mumbai), a PhD from the University of Pennsylvania, was a post-doctoral fellow at the Economics Research Center and an Associate of the Committee on Southern Asian Studies at the University of Chicago, and taught at the University of Michigan and Williams College before joining the World Bank's Research Department in 1999. He serves on the editorial boards of several journals, and is a member of the Successful Societies Program at the Canadian Institute for Advanced Research (CIFAR), and affiliated with research institutes and NGOs in India, the US, and the UK.



### **Richard Record**

LEAD ECONOMIST, MACROECONOMICS, TRADE AND INVESTMENT GLOBAL PRACTICE, WORLD BANK

Richard Record is the Lead Economist for Malaysia in the World Bank Group's Macroeconomics, Trade and Investment Global Practice. Based in Kuala Lumpur, he manages the Bank's engagement on economic policy issues in Malaysia, including publication of the flagship Malaysia Economic Monitor and the report on Malaysia's Digital Economy – A New Driver of Development. Richard has previously worked across a number of countries in the East Asia and Africa regions, managing programs on macroeconomics, trade and private sector development, including assignments based in Lilongwe, Vientiane and Hanoi. He holds bachelors, masters and doctoral degrees in economics respectively from the London School of Economics, the School of Oriental and African Studies and the University of Manchester.

Singh has published 9 books and over 100 scholarly articles. His latest book is: *Sweet Talk: Paternalism and Collective Action in North-South Trade Negotiations* (Stanford, 2017). His book *Globalized Arts: The Entertainment Economy and Cultural Identity* (Columbia, 2011) won the American Political Science Association's award for best book in information technology and politics.
