

EBA can inform policymaking and trigger reforms based on cross-country benchmarking










Seed registration score

Measures of regulatory discrimination


- Greece, Denmark, Poland, Spain and Zambia have the highest number of nondiscriminatory regulations in place
- Ethiopia, the Lao People's Democratic Republic and Myanmar have the fewest.
- Only a third of countries allow the private sector to carry out the seed certification process.
- While 38 countries allow foreign companies to transport goods into their country from outside, only 4 allow them to transport goods between two locations within the country.





Measures of accessibility of the information


- EBA measures whether Governments make regulatory information available to the public (e.g. licensing requirements, fee schedules, official catalogs).
- Denmark and Spain have the highest number of good practices and Rwanda has the fewest.
- While 75% of the countries have official catalogs listing new registered seeds or fertilizer products, fewer than half make them available online.



Number of good practices related to access to information
















Share of total countries (%)









Cost of variety registration



Time of variety registration
















Cost to register imported tractors








