LJD Week offers exceptional opportunities:


- To connect with top legal professionals in the development community.




EVENT FORMATS

INSPIRING—TED-STYLE TALK

Presentation of a well-formed and compelling new idea that challenges existing beliefs.

ILLUMINATING—LIGHTNING TALK

Presentation in which the presenter shares innovative ideas.

INQUISITIVE—INTERVIEW

Interview with approximately five questions.

INFORMATIVE—FIRESIDE CHAT

Fast-paced conversation between 2-3 speakers, where different points of view around a common and well identified topic are covered.

ARGUMENTATIVE—COURTROOM

The topic is presented by two sides (prosecutors and defendant), that are in disagreement.

CHALLENGING—Q&A

Questions around a common theme are submitted by LJD Week 2018 participants and answered by an expert.

ENGAGING—GAME/QUIZ

Game or quiz with audience.
